CATEGORY DEFINITIONS

CATEGORY NUMBER	COLOR	ENVIRONMENTAL CONDITION OF PROPERTY
1	White	Areas where no storage for one year or longer, release, or disposal of hazardous substances or petroleum products has occurred (including no migration of these substances from adjacent properties). Additionally, includes areas where no evidence exists for the release, disposal, or migration of hazardous substances or petroleum products; however, the area has been used to store less than reportable quantities of hazardous substances (40 CFR 302.4) or 600 or fewer gallons of petroleum products.
2	Light Blue	Areas where only storage of hazardous substances in amounts exceeding their reportable quantity or petroleum products exceeding 600 gallons has occurred, but no release, disposal, or migration has occurred.
3	Light Green	Areas where storage, release, disposal, or migration of hazardous substances or petroleum products has occurred, but at concentrations that do not require a removal or remedial action.
4	Dark Green	Areas where storage, release, disposal, or migration of hazardous substances or petroleum products has occurred, and all removal or remedial actions to protect human health and the environment have been taken.
5	Yellow	Areas where storage, release, disposal, or migration of hazardous substances or petroleum products has occurred, and removal or remedial actions are underway, but all required actions have not yet been implemented.
6	Red	Areas where storage, release, disposal, or migration of hazardous substances or petroleum products has occurred, but required removal or remedial actions have not yet been initiated.
7	Grey	Areas that are not evaluated or require additional evaluation.
